PROTECTIVE MEASURE

The Ministry of Health, as the administrative authority competent pursuant to Section 80(1)(h) of Act No 258/2000 on the protection of public health and amending certain related acts, as amended (hereinafter referred to as “Act No 258/2000”), **hereby orders** the following Protective Measure in accordance with the procedure laid down in Section 68(1) of Act No 258/2000 to provide protection against the introduction of COVID-19, a disease caused by the new SARS-CoV-2 coronavirus:

With effect from 11th October 2021, 0:00 in relation to point III. 1 of the Ministry of Health’s Protective Measure of 10th of September 2021, ref. no. MZDR 20599/2020-116/MIN/KAN with reference to the Ministry of Health Protective Measure of 27th September 2021, ref. no. MZDR 20599/2020-120/MIN/KAN and with reference to the Ministry of Health Protective Measure of 29th September 2021, ref. no. MZDR 20599/2020-121/MIN/KAN, a list of countries, or their parts, with a low, medium and high risk of COVID-19 transmission is issued:
